Sl. No. **The school is directed to ensure that :**


- 1 The total number of sections of the school shall be restricted to 12 as per the number of sections running during inspection. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law, subject to availability of class rooms of greater than 500 ft dimension
- 2 The Math lab needs to be further stocked. The science lab also needs further improvement. The school shall upgrade these labs as per sops issued by the Board within 3 months and submit compliance on SARAS.
- 3 The CWSN Toilets constructed by the School do not have enough space to negotiate the movement of the Wheel Chair. Further they are on a raised platform. The school is required to construct Separate toilets for Girls /boys on every floor with permanent signboard as per RPWD Act and Board's guidelines (https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) and submit the video graphic compliance within 3 months
- 4 The School is required to upload the appointment letters of the Special Educator in compliance within 3 months.
- 5 The school has improved the library infrastructure, but the newly installed furniture needs to be painted and sharp edges removed for safety of children. The stools in the library are inappropriate and chairs should be provided instead. The school shall improve the seating arrangement, furniture in the library and upgrade it as per SoP of the board within 3 months and submit compliance on SARAS.
- 6 The school shall conduct training of its teachers with CoE Prayagraj within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
